

- 12. Drawing of Legal and Survey samples of drugs, cosmetics and medical devices from the manufacturing & sales / distribution premises including the Govt. establishment.
- 13. When the samples drawn by the Central Drugs Inspector are declared spurious / adulterated / grossly sub-standard etc., the cases are investigated and prosecution are launched in the appropriate court after obtaining necessary sanction from the Drugs Controller General (India).

- 18. To co-ordinate for answering the Parliament Questions and for obtaining the data from various State Licensing Authorities under the zone.
- 19. Preparation of Monthly / Quarterly / Annual Reports.
- 20. To participate in the joint inspection with respect to grant of permission in Form CT-11/CT-14/CT-15 as per requirements.
- 21. To participate as observers in international regulatory agencies inspections as and when directed by Directorate.

The Central Drugs Standard Control Organization (CDSCO), South Zone, Chennai was started during the year 1968 in the Custom House, Chennai-1 headed by Assistant Drugs Controller (India). The Zonal office of the CDSCO was initially created to co-coordinate with the various State Drugs Controllers (who are the Licensing Authority under the Act) for uniform implementation and smooth enforcement of the provisions of Chapter IV of the D&C Act and Rules. The South Zone office had jurisdiction over the

states of Tamil Nadu, Andhra Pradesh, Karnataka, Kerala and Union Territory of Pondicherry. During the year 1979 this office was upgraded with Deputy Drugs Controller(India). A sub Zonal office headed by an Assistant Drugs Controller (India) with the jurisdiction over the State of Andhra Pradesh had started and functioning during the year 1995. A new Sub Zonal office of Bangalore was set up with Assistant Drugs Controller (India) on 01.09.2009 for the State of Karnataka. At present the South Zone office is functioning in CDSCO Bhawan, No. 37, Jothi Venkatachalam Street, Vepery, Chennai – 600 007 has the jurisdiction over the States of Tamil Nadu, Kerala, Union Territories of Puducherry and Lakshwadeep.
