GUIDANCE DOCUMENT ON MARKET STANDING CERTIFICATE (MSC) AND NON-CONVICTION CERTIFICATE (NCC)

- PURPOSE: To provide guidance to Indian manufacturers or importers for submission of application to the Licensing Authority for obtaining Market Standing Certificate or/and Non Conviction Certificate for licensed Medical Devices for tender purposes, etc.
- 2. SCOPE: This guidance document is applicable to those medical device manufacturers or importers in India who are having valid manufacturing license or import license under the Medical Devices Rules, 2017 and intend to obtain Market Standing and/or Non-Conviction Certificate for licensed medical devices for tender purposes, etc.
- 3. MODE OF SUBMISSION: Online (www.cdscomdonline.gov.in)

4. GUIDANCE:

An application shall be made to the Central Licensing Authority (CLA) for Class C and Class D medical devices licensed under a valid manufacturing license or for devices of all classes licensed under a valid import license for sale or distribution of medical devices under the Medical Devices Rules, 2017.

In case of Class A and Class B medical devices licensed under a valid manufacturing license for sale or for distribution of medical devices under the Medical Devices Rules, 2017, the applications shall be made to the State Licensing Authority (SLA).

- **4.1 Covering Letter**: The covering letter should clearly specify the intent of the application. The list of documents that are being submitted as well as any other important and relevant information may be provided in the covering letter. The covering letter should be duly signed and stamped by the authorized signatory, indicating the name & designation of the authorized signatory along with the name and address of the firm.
- **4.2 Application Form:** The system-generated application form should reflect the license number and the product list for which MSC or/and NCC is requested.
- **4.3 Import/Manufacturing License:** A valid copy of license to manufacture/import for Sale or for Distribution issued by the concerned Licensing Authority.

4.4 Market Standing Details (only for MSC): As an evidence for the market standing of devices in the Indian market, the applicant shall submit the following:

- i) In case of Import: Sales details duly certified by CA or Bills of Entry
- ii) In case of manufacturing: Sales details duly certified by CA

The above-mentioned details shall be submitted for the duration of last 3 years from the date of submission of the MSC application or from the date of grant of license, whichever is later, for all applied products.

4.5 Legal Undertaking shall be submitted on a 100 Rupees registered notarized stamp (recently notarized) by the manufacturer or importer stating that no action has been initiated against them or been convicted due to adverse events, market complaint and Not of Standard Quality (NSQ) report of any product in India as prescribed in **Annexure A**.

Note:

PLOF HEALT

- The validity of the MSC will be 1 year from the date of issuance or till validity of license, whichever is earlier, provided no regulatory action has been initiated by the Licensing Authority on the applied products.
- In case of MSC, the applicant may ensure that all applied brands and model numbers are mentioned in the submitted market standing details (as mentioned in Section 4.3 of this document).
- Please refer Annexure B for the checklist of documents to be submitted with the application.
