Sub: Drug safety label change of Rabies Vaccine (Human) marketed in India - regarding.

Ref: PvPI- Signal review Panel recommendations for the drug safety label change of Anti-Rabies Vaccine marketed in India.

Sir,

With reference to the subject cited above, it is to inform that Signal Review Panel (SRP) of Pharmacovigilance Programme of India (PvPI) concluded that there is a strong relationship between anti-rabies vaccine and Erythema Multiforme, based on spontaneously received Adverse Drug Reactions (ADRs) data and published literature. Hence, the SRP has recommended that Erythema Multiforme needs to be inserted in the drug safety label of Anti-Rabies vaccine, manufactured and imported in India.

Accordingly, all the manufacturers and importers of rabies vaccine are hereby directed to ensure that Erythema Multiforme is inserted in the drug safety label of the subject vaccine and also submit the revised Prescribing Information/Package Insert to this Directorate for further review and approval of the same.
