Whereas, M/s Stiefel India Pvt. Limited, 401-402, A-wing, 4th Floor, Floral Deck Plaza, Opp. Rolta Bhavan, Central MIDC road, Andheri (E), Mumbai – 400 093 is holding two Registration Certificates i.e. RC No. COS-843/15 dated 8th October 2018 (valid till 4th October 2021) issued for import of cosmetics manufactured by M/s Laboratorios Stiefel Ltda., Rua Professor, Joao, Cavalheiro Salem, 1077, Guarulhos-SP, Brazil and RC No. COS-001445 dated 5th July 2019 (valid till 3rd July 2022) issued for import of cosmetics manufactured by M/s MAPPEL INDÚSTRIA DE EMBALAGENS S.A., Avenida Deputado Oswaldo Moraes e Silva, No. 55, Vila Conceicao, Diadema-Brazil.

And Whereas, M/s Stiefel India Pvt. Limited, has communicated to this directorate vide Post Approval Notification Number COS/Form42/FR/2019/7869 dated 25.05.2021 regarding change in address, in turn a show cause notice dated 15.06.2021 was issued to the firm due to non-compliance of Condition number 4 of Registration Certificate.

Now, in response to Show cause notice dated 15.06.2021, M/s Stiefel India Pvt. Limited has submitted a reply wherein it has accepted the Invalidity of the aforementioned Registration Certificates due to the reasons that the address of the firm had changed on 28th December, 2020 from 401-402, A-wing, 4th Floor, Floral Deck Plaza, Opp. Rolta Bhavan, Central MIDC road, Andheri (E), Mumbai – 400 093 to 1, Battery House, Bhulabhai Desai Road, Mumbai 400026 and the relevant submissions

for change in Indian Agent address were not progressed for the two Registration Certificates as the cosmetic products registered under the aforementioned Registration Certificates have been discontinued by the company and the company is no longer importing and marketing these products in the country.

Therefore, the two registration certificates RC No. COS-843/15 dated 8th October 2018 (valid till 4th October 2021) and RC No. COS-001445 dated 5th July 2019 (valid till 3rd July 2022) pertaining to M/s Stiefel India Pvt. Limited, 401-402, A-wing, 4th Floor, Floral Deck Plaza, Opp. Rolta Bhavan, Central MIDC road, Andheri (E), Mumbai – 400 093 have been cancelled.
