OFFICE ORDER

Subject: Transfer of certain functions and delegation of powers to the zonal offices of CDSCO under Rule 22 of the Drugs and Cosmetics Rules, 1945 – regarding.

It has been decided with the approval of the Central Government to delegate the following powers to the zonal and sub-zonal offices of the Central Drugs Standard Control Organization under Rule 22 of the Drugs and Cosmetics Rules, 1945, which were exercised by the undersigned as Licensing Authority, as prescribed under rule 21(b) of the said rules, till further orders, as under:

1. To sign test licences in Form 11 of the Drugs and Cosmetics Rules, 1945 for import of small quantities of drugs for examination, test or analysis originating under their area of operation as stated below.
2. The receipt of the applications and grant of test licence for import of drugs for the purpose of the clinical trials shall however, be with the CDSCO, HQ, New Delhi.
3. These powers shall be exercised by the designated officers as stated below or their next subordinate officer, not below the rank of Assistant Drugs Controller, India and who is qualified to sign such licences.
4. The pendency position in respect of applications for licensing will be reflected on the web-site of CDSCO and the position shall be updated on a monthly basis to the CDSCO, HQ.
