
Subject:-Transfer of certain functions and delegation of powers to zonal offices of CDSCO under Rule 22 of Drugs & Cosmetics Rules

It has been decided with the approval of Central Govt. to delegate the following powers which were exercised by the undersigned as Licensing Authority as prescribed under Rule-21(b) to the zonal officers as stated below:-

1. No. Objection certificates for grant of license to manufacture drugs for the purpose of examination, test or analysis and provided under Rule 89 of the Drugs & Cosmetics Rules.
2. No objection certificate for grant of permissions for manufacture for export only of unapproved/approved new drugs and drugs banned under sanction 26-A of the Drugs & Cosmetics Act.
3. Permit for import of small quantities of drugs for personal use under Form-12B of the Drugs & Cosmetics Rules.
4. No objection certificates for grant of permissions for import of dual use items, not for medicinal use.

Following officers of the respective zone will exercise the above powers within the jurisdiction w.e.f. 20th June'2011 till further order.
